Notice is hereby given that the annual general meeting of the shareholders of Lincoln Minerals Limited (Company or LML) will be held at 11.30am (Adelaide time) on Monday 23 November 2009 at 28 Greenhill Road, Wayville SA 5034 for the purpose of transacting the business referred to in this Notice of Annual General Meeting (Notice).

B. To consider, and if thought fit, to pass the following resolutions each as an **Ordinary Resolution**:

1. Resolution 1: Re-election of Mr Richard V Ryan

'To elect as a Director of the Company Mr Richard V Ryan who retires by rotation and being eligible, offers himself for re-election.'

2. Resolution 2: Re-election of Mr Peter E Cox

'To elect as a Director of the Company Mr Peter E Cox who retires by rotation and being eligible, offers himself for re-election.'

3. Resolution 3: Remuneration Report

'To adopt the remuneration report as set out in the 2009 Annual Report.'

Voting Entitlements

The Company has determined that, in accordance with Regulation 7.11.37 of the *Corporations Regulations 2001* (Cth), the Company's shares quoted on ASX at 7:00 pm (Adelaide time) on Thursday 19 November 2009, will be taken, for the purposes of the Annual General Meeting, to be held by the persons who held them at the time. Accordingly, those persons are entitled to attend and vote at the meeting.

Proxies

A shareholder who is entitled to attend and vote at the Annual General Meeting may appoint up to two proxies to attend and vote on behalf of that shareholder. A proxy form is included with this Notice of Annual General Meeting. If you require an additional proxy form, please contact Computershare Investor Services Pty Limited, GPO Box 242, Melbourne, VIC 3001, Australia.

If a shareholder appoints two proxies, the appointment of the proxies may specify the proportion or the number of that shareholder's votes that each proxy may exercise. If the appointment does not so specify, each proxy may exercise half of the votes. Fractions of votes will be disregarded.

A proxy need not be a shareholder of the Company.

To be effective, the Company must receive the completed proxy form and, if the form is signed by the shareholder's attorney, the authority under which the proxy form is signed (or a certified copy of the authority) by no later than 11:30am (Adelaide time) on Saturday 21 November 2009.

The proxy's appointment and, if applicable, the authority appointing an attorney, must be sent by post or fax to the Company's share registrar, Computershare Investor Services Pty Limited, as listed below:

Proxies given by corporate shareholders must be executed in accordance with their constitutions, or signed by a duly authorised officer or attorney.

A proxy may decide whether to vote on any motion, except where the proxy is required by law or the constitution to vote, or abstain from voting, in their capacity as proxy. If a proxy is directed how to vote on an item of business, the proxy may vote on that item only in accordance with the direction. If a proxy is not directed how to vote on an item of business, the proxy may vote as he or she thinks fit.

If a shareholder appoints the chairperson of the meeting as the shareholder's proxy and does not specify how the chairperson is to vote on an item of business, the chairperson will vote, as proxy for that shareholder, in favour of that item on a poll.
