

# Quarterly Activities Report

Period Ending December 2018



## Highlights

- **Lincoln Secures 100% of Mineral Rights**
- **Available funds of \$2.1 million at 31 December 2018**

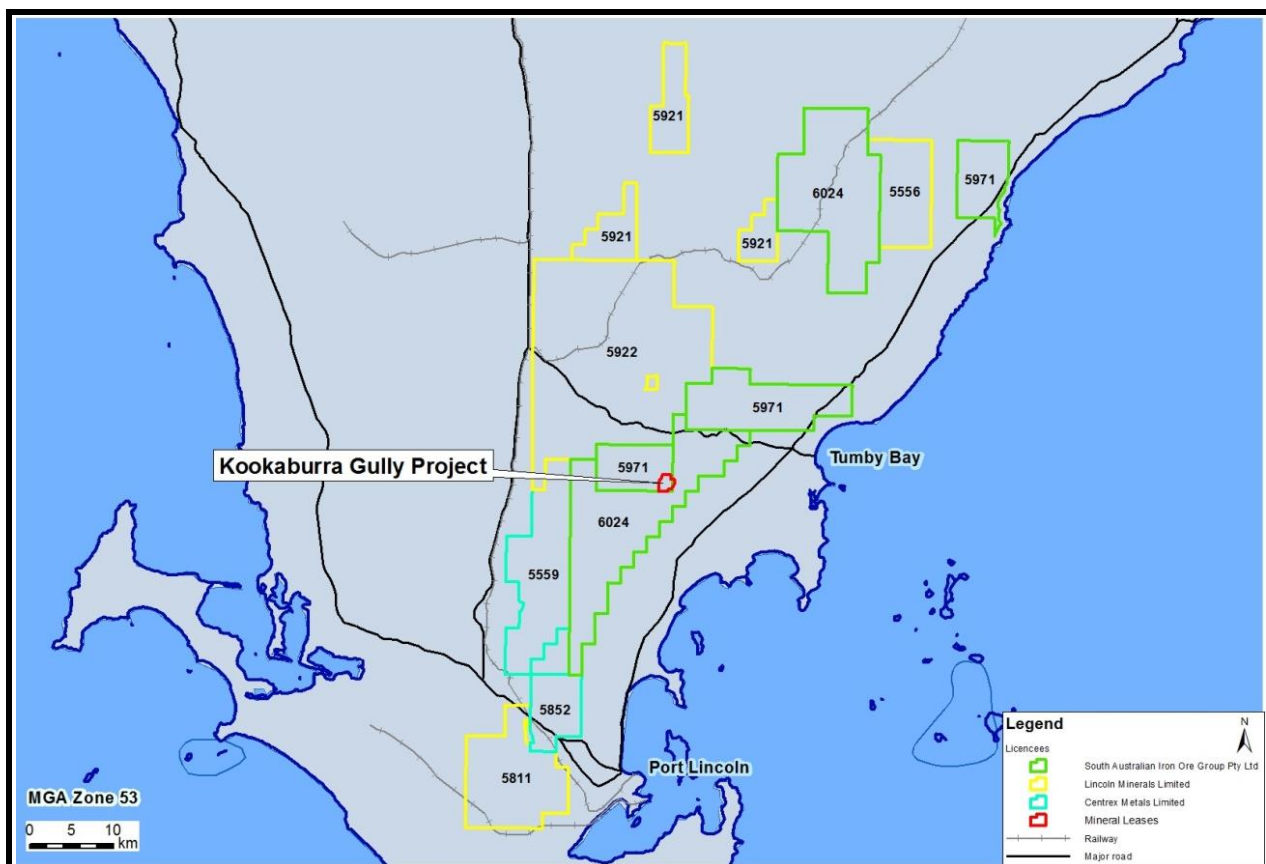


Figure 1: Lincoln Minerals newly acquired 100% interest

Lincoln Minerals Ltd (ASX:LML) ("Lincoln" or the "Company") announced that an agreement had been reached to acquire four Exploration Licences (EL) for nominal consideration during the quarter. The EL's will be acquired from Centrex Metals Ltd (ASX:CXM), South Australian Iron Ore Group Pty Ltd (SAIOG), Wugang Australian Resources Investments Pty Ltd and WISCO Resource Group Corporation Limited and represent their interest in South Australian tenements with completion to occur following various approvals. Lincoln will acquire 100% interest in EL5852 (Greenpatch) and EL5559 (Vanilla) held by licence holder Centrex (shown in blue) and also EL5971 (Tumby Bay) and EL6024 (Mount Hill) held by licence holder SAIOG (shown in green) as shown pictorially in Figure 1. Lincoln currently holds all non-iron rights in these EL's.

## ***Kookaburra Gully Graphite Project, SA (100%-owned)***

Lincoln is working towards engaging an external consultant to provide a report on the Kookaburra Gully Project with a special focus on the technical, economic and marketing aspects of the project. The report is expected to be completed in the June Quarter 2019 and therefore, Lincoln is continuing to undertake measures to stabilise expenditure and investigate new opportunities to enable growth of Lincoln's resource business.

Lincoln continued its stakeholder engagement and environmental monitoring programs for Kookaburra Gully graphite project during the quarter, with Lincoln's Board formulating options to fund project development and finalise its Program for Environment Protection and Rehabilitation (PEPR).

## ***Other SA Projects***

No significant exploration or development work was undertaken during the Quarter on Lincoln's other Eyre Peninsula tenements.

## ***Corporate***

At 31 December 2018, Lincoln had \$2.1 million in cash at bank.

## Tenements

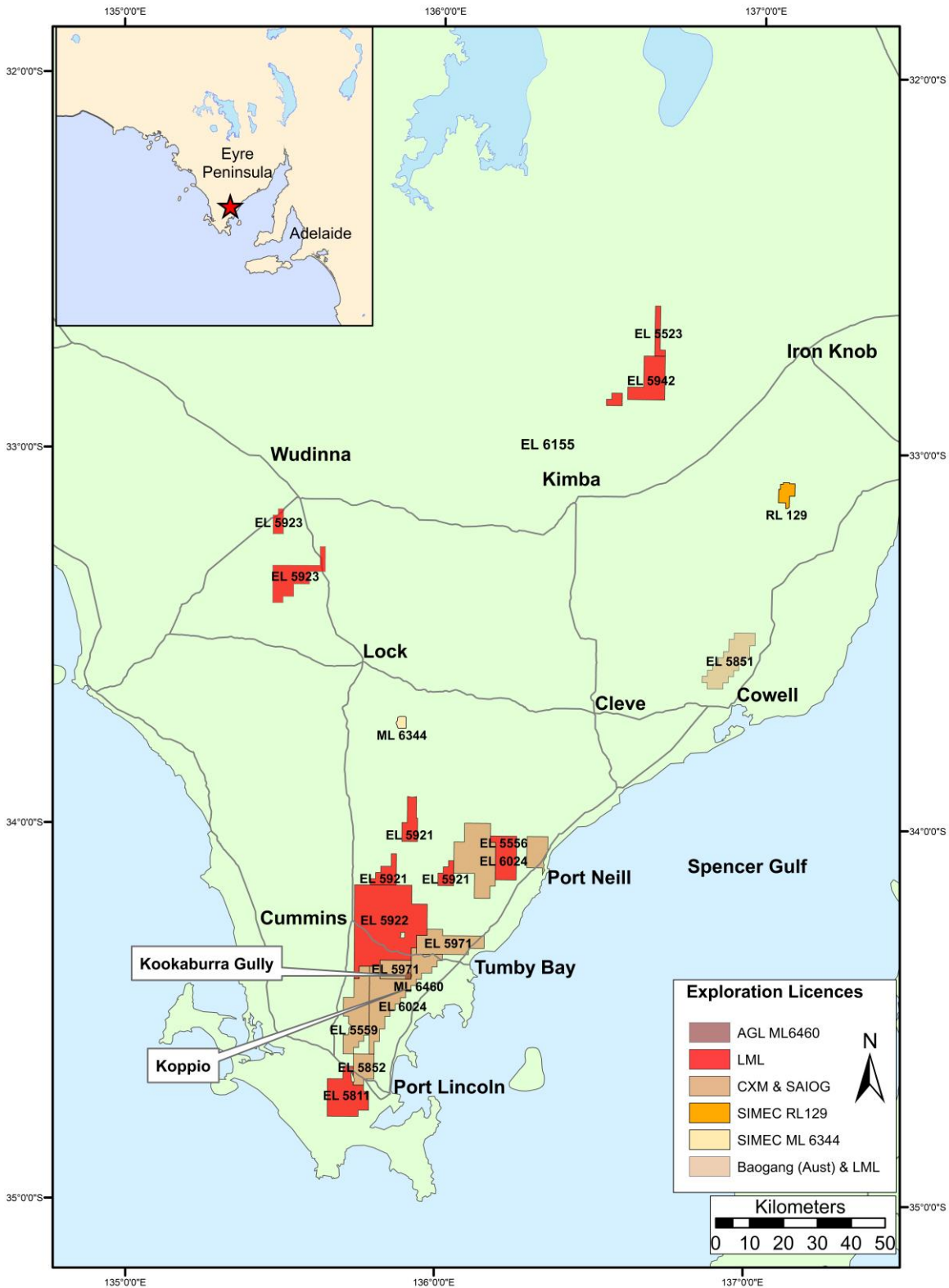
The status of all Exploration Licenses (ELs) as at 31 December 2018 including SAIOG, CXM and Baogang ELs on which Lincoln Minerals is an operator, is shown in the following tenement schedule and map. All ELs are current to 2019 and as noted above, four tenements held by Centrex/SAIOG are pending final approvals before 100% interest is transferred to Lincoln (shaded grey in Table below). No tenements were acquired or disposed of during the quarter.

Lincoln Minerals holds exploration rights to South Australian lease holdings totalling 1,988km<sup>2</sup>, all located on Eyre Peninsula. The Nantuma tenement (EL 5923) was reduced by 40km<sup>2</sup> and renewed for a further two years during the quarter.
